3. **Bid Price**

- The bidder shall quote the rate in the above format of quotation on your **firm's pad** with your **signature & seal**. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
- All duties, taxes and other levies payable by the bidder, shall be included in the total price.
- The rates quoted by the bidder shall be fixed for the duration of the contract.
- The prices should be quoted in Indian Rupees only.
- Each bidder shall submit only one quotation.
- Telex or Fascimile quotations are not acceptable.

- g The bid should be submitted along with EMD for **Rs.5,000/-** by Bank draft in favour of **VVN A/c, Kendriya Vidyalaya, NO.II, CRPF, BHUBANESWAR payable at BHUBANESWAR.**
- h The firm should enclose supporting documents regarding **registration of Contractor, GIST, ITPAN and valid labour license etc.**

**4. Responsibilities of contractor**

Contracting agency shall be responsible for any damage to the property/equipment/material of the Vidyalaya by its personnel. The injury or death of worker, if any, during the course of work is the sole responsibility of the contractor. The school will not bear any responsibility for it.

**5. Evaluation of quotations:**

The purchaser will evaluate and compare the quotations determined to be substantially responsive, i.e. which are:

- Properly signed, and
- Conform to the terms and conditions and specifications.

The evaluation would be done for all the work put together. The bidder who has quoted for partial work of any one or more item(s) would be treated as non-responsive. Purchaser will award the contract to the responsive bidder whose total cost for all the work put together is the lowest.

**6. Award of contract:**

- The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest price as per para 5 above. The bidder whose bid is accepted will be notified of the award of the contract by the office prior to expiration of the quotation validity period.
- Payment shall be made within 30 days after completion of work.
- Notwithstanding the above, the purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.

**7. Validity of quotations**

The quotation shall remain valid for a period of one year from **16/07/2021**.

**8. Last date and time of receipt of quotations:**

You are requested to submit the sealed quotation to the Principal superscribing on the envelope as "**Quotations for M & R work** (painting work)", **due on 15/07/2021 latest by 02.00 P.M.** The quotations shall be opened at Kendriya Vidyalaya, **No.II, CRPF, BHUBANESWAR** on **16/07/2021 latest by 10.00 AM**. The bidders or their representatives who choose to be present at the time of opening of quotation are invited to do so.

The purchaser looks forward to receiving the quotation and appreciate the interest of the bidders in the KVS.
